Financial Report- Olson

Financial report through March 19th given

2013 Budget- Olson

Larry presented the operating budget overview, January through December 2013.

2013 CCC- Machkhashvili

Missy reported on the 2013 CCC wrap-up committee meeting. We have a contract in hand for 2014 CCC at the Crowne Plaza to be reviewed and signed. The committee is looking for new chairperson for the conference It was moved, seconded, and carried to Reserve the Crowne Plaza for 2013-2014

Ebert aks have we looked elsewhere to source better pricing? The recommendation is based upon knowing what to expect and having our budget locked in at the Crowne.

Tony Ebert would like to join the conference committee next year if time permits.

Marketing & Public Relations- Savaryn

Terri reported on her phone conference-call with John Maloney and Paul Hugunin from MN Grown. Hugunin is enthusiastic to help the MGGA with funding for the Discover MN Passport and assisting with the legislative process for the billboard campaign. MN Grown has agreed to help with printed material, collateral material via grant money. Money made from Passport Sales will fund the billboard campaign. Also discussed was a publication and directory to which MN wineries should join MN Grown and feature Farm to table products.

Website- Ebert

Tony reported on his findings with the current state of the MGGA website and where we would like to go. Functionalities of the future website are: member management services, payment functionality, forums, blogs and classifieds. Our website serves as the face of the MGGA and should be convenient to use by our members. After seeking several quotes for design firms with MN connections he presented 4 companies with varying degrees of functionality. Tony recommends Minnesota Website Company. Minnesota Website Company will keep a database of our members.

Website Committee, Tony Ebert, David Mohn, Missy Machkhshvili, Cheri Anderson Ron recognizes that the website will cost a significant amount of money and that's ok. He has requested that

three providers present options for the website at the May meeting.

The Swenson Project- Barnes

Seth Reid has agreed to take on the Elmer Swenson Project and gather the information from participating vineyards. Mark Hart will supply Seth with the existing database. 6 vineyards might participate in sharing their information. 25-30 people were originally in the project taking each 6-8 varieties from Elmer's farm. 100th anniversary of Elmer's Birthday

Legislative Committee- Maloney

John gave a brief history of his position on the legislative committee and the work the committee has done since 2011. Today John met with Frank Ball and Paul Kaspack, from the MLBA with Kieth Smiley to discuss their relationship with MN farm wineries going forward with legislation. They appreciated the MGGA's help at the

capitol with the excise tax. MLBA is a huge player in the alcohol industry. They really recognize the importance and influence our industry has at the capitol.

Events Activities- Machkhashvili

Suggestion to contact Four Daughters regarding Annual Picnic, Missy will make contact and report at next meeting. The Arboretum has placed an ad in the NFTN for the 4x4 vetting July 25, 2013. The Spring Regional Seminar has been scheduled for April 6th at Millner Heritage Winery 1^{st.} Topic; pruning seminar by the Thulls. Future Regional Seminars include: Canopy Management, Harvest/ Ripening Parameters, University of MN Research Update.

2013 ICCWC- Gardner

Gary sent a report for the ICCWC. Date has changed to August 16, 2013

Viticulture Best Practices- Geary

Working on creating lists of what Best Practices are. Have not progressed too much since the CCC. Topics that will be discussed at the committee level are; Site selection, financial sustainabilit, canopy, pruning, crop load estimations. Bob Olson may have some vineyard certification info (food certification standards).

Enology Best Practices- Schwickert

The committee met at the CCC. Kent is constructing the committee membership to become a cooperative effort among MGGA and MNFWA.

Mohn gave a report of the benefits and off-setting of costs to move the current MGGA website to YourMembership.com. After the website committee met with a user group through MSAE, they recommend that the MGGA go with Yourmembership.com.

Motion for the MGGA to subsidize 1 case per participating winery for the participating restaurants was moved, seconded and carried.

2015 CCC Site Selection- Unverzagt

Steve gave a summary of the sites visited with Helms-Briscoe on December 2, 2013. Gary Gardner suggested we approach the ICCWC sponsoring hotels with an opportunity to bid on the conference to show our appreciation for their sponsorship.

Passport to MN Wines- Machkhashvili

Missy gave a report on the 2013 Passport sales and marketing/advertising impact. Terri made a motion to use some of the money generated from the passport sales to promote the continued sale of the passport, billboard and other marketing meeting at the Marketing Committees discretion, with a cap on use of \$5000. Moved, seconded and carried

2013 ICCWC- Gardner, Cook

Gary gave the financial report on the 2013 ICCWC. 3D printing for medals with smaller ribbons were suggested for 2014. Josie Boyle has joined the ICCWC Committee to assist with marketing in 2014.

Legislative Committee- Maloney

John gave an update on the Roadside signage, Distilled Spirits Purchase, Taxes on Distilled Spirits Purchases and off site warehousing. If wineries are having trouble with Specific Service Signs they can file an exemption. John also mentioned Wine America, a lobbying organization that wineries should become members of.

Irv reported that MNFWA is pursuing a VQA check-off. The committee is pursuing a grant to write a book on Viticulture Best Practices. Josie Boyle will take up the Winery Best Practices Committee Chair with direction from Ron Barnes.

Dave did not receive any responses to membership nominations to the Board. Senator John Howe may be interested in a position and will receive a follow-up phone call. John Maloney provided a few contacts that may also be interested.

Marketing Committee- Savaryn

The Marketing committee will construct a formal marketing budget for 2014.

The MGGA would like to add the Cannon Falls Art and Wine Festival banner to the website for greater exposure as a sponsor. The Marketing Committee would like to develop a festival committee to fold under its name to check the feasibility for a 2014 MGGA Festival. BLANK will talk with Keith Smiley regarding his interest in using the MGGA license for the 2014 Cannon Falls Art and Wine festival and will report back at the January Board meeting.

Other Business

Terri made a motion to give of percentage of the Winter Wine Fest ticket sales back to the wineries to subsidize the increased wine use. Motion was seconded and carried.
